Erik Alm reported on plans for a Veterans Memorial for Saunders County which will be located on the Courthouse grounds.

Harrell responded to questions about placement of the box culvert on 23rd Street. Harrell stated she and Dave Jansa attended training on signs and sign maintenance; we need to focus on compliance, a sign inventory, and a maintenance plan. Beavers reported he attended a flood plain conference in Columbus, and changes are recommended in zoning and flood plain regulations.

The public hearing on application for Conditional Use Permit to operate a dance academy in R-2 Zoning District on Lot 1 and 2, and part of Lots 3, 10, 11, 12 and the vacated alley lying contiguous with the aforesaid lots, all in Block 115, and also part of vacated Elm Street, County Addition to the City of Wahoo, commonly known as 345 East 10th Street, as filed by Megan Reisen, was declared open by the Mayor at 7:24 p.m. No comments by the public were offered. Motion by Kavan, seconded by Svoboda to close the public hearing at 7:25 p.m. Roll call vote: Kavan, yes; Svoboda, yes; Tyler, yes; Krejci, yes; and Dunbar, yes. Absent and not voting: Lawver. Motion carried.

Megan Reisen, owner of MLR Dance, LLC, d/b/a Wahoo Dance Academy, is purchasing the property contingent upon approval of the Conditional Use. Parking and lighting was discussed. Krejci requested review of the use in twelve months.

Council Member Krejci seconded said motion. The Mayor put the question and instructed the Clerk to call the roll for the vote thereon. The motion having been carried by the affirmative votes of no less than three-fourths of the members of the Council, the Mayor declared the statutory rules in regards to the passage and approval of ordinance be suspended so that Ordinance No. 2145 may be read by title and moved for final passage in the same meeting.

Information regarding amendment of sight triangle was reviewed. Public hearing was held on November 14, 2013.

Harrell reported an opinion was received that value for a parcel of City of Wahoo property including vacated Maple Street between A and B Street was less than \$5,000. Declaration as surplus property, lease terms, minimum amount, and process was discussed. Harrell will prepare a resolution for consideration at the next meeting. Motion was made by Tyler, seconded by Krejci, to establish the value of surplus property as less than \$5,000, and table action to the next meeting. Roll call vote: Tyler, yes; Krejci, yes; Dunbar, yes; Svoboda, yes; and Kavan, yes. Absent and not voting: Lawver. Motion carried.

Trevor Wiskus addressed the Council stating Roundbale Logistics, LLC is new owner of property at 1159 North Chestnut, and the business, Harvest Auto & Machinery, will sell used vehicles and skidsteer loaders. They met with Beavers to discuss parking requirements and traffic flow. A Conditional Use Permit was issued for auto sales to the previous property owner by Ordinance No. 2049, with review by the Council. Conditions for use by new owners and one-year review were discussed.

Harrell reported that if an increase in pay for Mayor and Council is considered, this could affect filing fees for office. Increase would not be received until December 2015. Roll call vote: Dunbar, yes; Svoboda, yes; Krejci, yes; Kavan, yes; and Tyler, yes. Absent and not voting: Lawver. Motion carried.
