## Wahoo Public Library Wahoo, Nebraska November 14, 2023

The Council met in Regular session in the Wahoo Public Library, in compliance with the agenda posted at City Hall, Post Office, and First Bank of Nebraska, and the City of Wahoo website, with each Council Member being notified of the agenda prior to the meeting. The meeting was called to order by Mayor Gerald D. Johnson at 7:00 PM and opened with the Pledge of Allegiance. The public was informed of the location of posting of the Open Meetings Law. Roll call was taken with the following Council Members: Ryan Ideus: Present, Stuart Krejci: Present, Patrick Nagel: Absent, Chris Rappl: Present, Shane Sweet: Present, Carl Warford: Present.

Police Chief Joe Baudler reported on the annual statistics for the Police Department.

City Attorney Jovan Lausterer reported that there is no new information from Destiny Ministries regarding the Kennedy Campus Gymnasium or East Hall properties.

City Administrator Harrell reported on the status of projects throughout the city.

City Administrator Melissa Harrell reviewed the annual occupation tax report.

There is no new information regarding the North Chestnut Drainage.

Council Member Stuart Krejci motioned, and Council Member Carl Warford seconded to approve the consent agenda which included, acceptance of excused absence Council Member, approval of the October 24, 2023, minutes of the City Council, acceptance of minutes of the November 2, 2023, Planning Commission, and approval of claims. Utilities General Manager Ryan Hurst addressed the issuance of the combined utility revenue bonds and highlighted the projects that these funds will be used for.

## RESOLUTION OF NECESSITY

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF WAHOO, NEBRASKA, AS FOLLOWS:

1. The Mayor and Council hereby find and determine that it is necessary and advisable to construct additions and improvements to the City's Storm Water Sewer System (Storm Water Sewer District No. 2023-01) consisting of the following:

Installation of reinforced concrete storm sewer pipe of 18" (inch) diameter, with inlets, utility adjustments, manholes, site grading, and surface restoration and such other appurtenant improvements as necessary in North Highlands – Phase II Subdivision in the City of Wahoo, Nebraska

2. The Mayor and Council hereby find and determine that it is necessary and advisable to construct additions and improvements to the City's Sanitary Sewer System (Sanitary Sewer District No. 2023-01) consisting of the following:

Installation of an 8" (inch) PVC SDR26 solid wall sanitary sewer main, 6" (inch) PVC SDR26 solid wall sanitary sewer service lines, providing service connections to all lots, with manholes, site grading, and surface restoration and such other appurtenant improvements as necessary in North Highlands — Phase II Subdivision in the City of Wahoo, Nebraska.

3. The outer boundaries of Storm Water Sewer District No. 2023-01 and Sanitary Sewer District No. 2023-01 are as follows:

SAID STORM SEWER MAINS SHALL CONSIST OF REINFORCED CONCRETE SEWER PIPE WITH A DIAMETER OF 18 INCHES, TOGETHER WITH STORM SEWER INLETS AND OTHER NECESSARY APPURTENANT IMPROVEMENTS

5. The size, kind and location and terminal points of sanitary sewer system proposed to be constructed as part of said addition and improvements is as follows:

INSTALLATION OF AN 8" (INCH) PVC SDR26 SOLID WALL SANITARY SEWER MAIN, 6" (INCH) PVC SDR26 SOLID WALL SANITARY SEWER SERVICE LINES, PROVIDING SERVICE

CONNECTIONS TO ALL LOTS (LOTS 61-92), WITH MANHOLES, SITE GRADING, AND SURFACE RESTORATION AND SUCH OTHER APPURTENANT IMPROVEMENTS AS NECESSARY.

- 6. Reference is hereby made to the plans and specifications for said additions and improvements which have been reviewed and approved by JEO Consulting Group, Special Engineers for the City who has been employed for such purpose, and which, together with said Engineer's estimate of total cost for said additions and improvements have been filed with the City Clerk prior to the publication of this Resolution.
- 7. The Engineer's estimate of total cost for the proposed improvements for said Districts is as follows:

SANITARY SEWER IMPROVEMENT DISTRICT NO. 2023-01 STORM WATER IMPROVEMENT DISTRICT NO. 2023-01 \$275,000.00 \$113,000.00

- 8. It is hereby found and determined that the Storm Water Sewer Improvements and Sanitary Sewer Improvements constitute improvements of benefit to all properties located in North Highlands Phase II Subdivision to the City of Wahoo, and said improvements shall be made at public cost, but special assessments shall be levied against all property benefited thereby. Said storm sewer and sanitary sewer improvements shall be financed by the issuance of the City's General Obligation Sewer Bonds issued pursuant to Neb. Rev. Stat. § 17-925.
- 9. There being no petition filed in opposition to this resolution as provided by Neb. Rev. Stat. §17-916, the Mayor and City Council hereby orders the making of the improvements described herein.

No vote taken at this time.
